Strategic Investments In Albania

For an Amendment to Law No. 55/2015 "On Strategic Investments in the Republic of Albania"

On 18.12.2019 was approved the Law No. 89/2019, for an Amendment to Law No. 55/2015 "On Strategic Investments in the Republic of Albania", published in the Official Gazette No. 1, dated January 15th 2020.

Law No. 89/2019, has amendment Article 36 of Law 55/2015 "On Strategic Investments in the Republic of Albania" by postponing the deadline for submitting applications to be categorized as "Strategic

Investment" until December 31st 2020.

Hereby, we recall that the Law no. 55/2015 "On Strategic Investments" first entered into force on January 1st 2016, and the main goal was promoting and increasing the strategic domestic and foreign investment in the sectors of the economy considered as strategic sectors, through the establishment of special favorable administrative procedures, and support services.



According to the Law, are considered to be as strategic sectors of the economy:

- a. Energy and mining;
- b. Transport, electronic communications infrastructure and urban waste;
- c. Tourism (tourist structures);
- d. Agriculture (large agricultural farms) and fisheries;
- e. Economic zone;
- f. Development priority areas;

Under the provisions of the Law 55/2015 (as amended), the assessment whether the strategic investment is of public interest or not, is based on:

- a. investment amount;
- b. period of investment execution;
- c. investment productivity and added value;
- d. creation of jobs;
- e. priority economic sector;
- f. regional and local economic development;

- g. development and improvement of conditions and standards for the production of goods and provision of services;
- h. Introduction of new technologies in order to increase competitiveness and effectiveness of the investment etc.

Depending on the category, the above mentioned projects benefit supportive measure like: Priority handling and prepaof documentation. ration support programs, support with assistive infrastructure, and provision of access to stateowned immovable property for the purposes of developing and executing strategic investment projects, pursuant to the legislation in force etc., so that strategic



domestic and foreign investments are attracted to one those sectors that are identified as strategic according to the law -

On Revaluation Of Immovable Property

As of January 14th 2020, has entered into force Law No. 90/2019 "On revaluation of immovable property", published in the Official Gazette no. 182 dated 30.12.2019.

Under the provisions of the Law, all individuals who own immovable properties, as well as those who own immovable prop-

erty in registration process shall be entitled to make a revaluation of their immovable property at □. market value until September 30th, 2020.

> The reevaluation could be done through an licensed independent expert act, or by the local directories of the National Agency on Cadaster.

The provisions set forth in Law 90/2019 are applied to properties which are registered with lower value compared to the market price.

The applicable deducted tax for the revaluation is 3 % of the difference

between the revalued amount and the value of the property registered prior to the revalu-



amount will then serve as a calculation basis for the Income Tax (capital gain tax) in cases of transfer of the Ownership Title of the Immovable Property in the future.

The capital gains in Albania are currently

taxed at a rate of 15%, therefore in cases of transfer of ownership in the future, the applicable tax would be 15% of the differ-

ence between the Selling Price and the revalued amount.

Meanwhile, with regard to legal entities owning immovable properties in Albania, the reevaluation at market value is done through an expert act issued by a licensed independent expert.

The Legal entities will have to pay 5% of the difference between the revalued amount and the registered amount of the immovable property -


