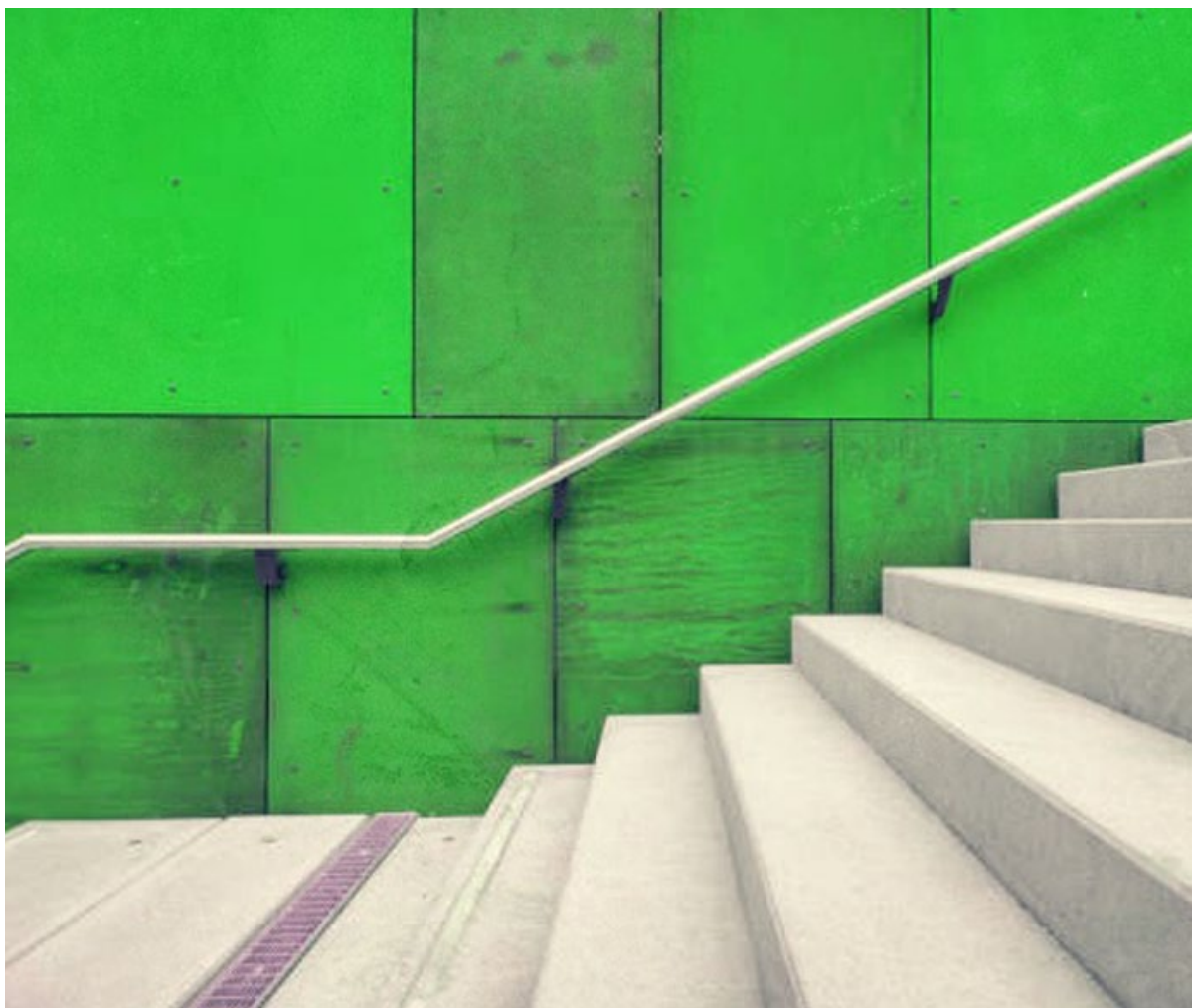

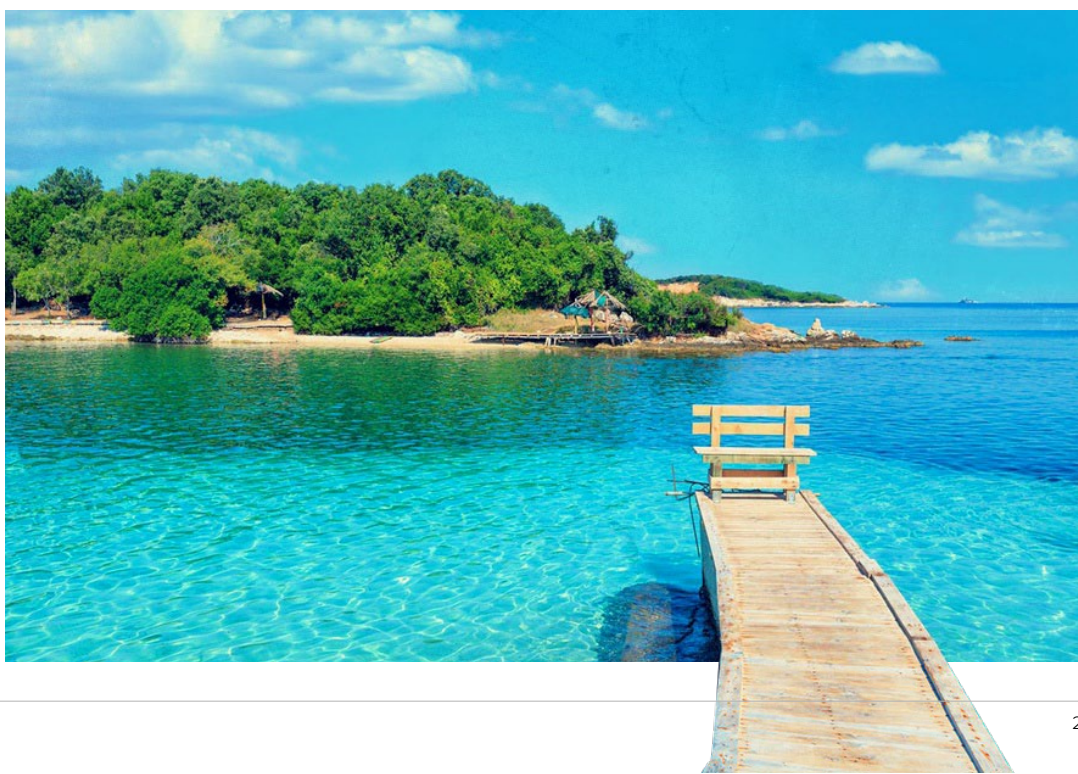
## Decision no. 569, dated 17.07.2019 “On the approval of the responsibilities, the organization and functioning of the National Agency of the Coastline”.

With Decision no. 569, dated 17.07.2019, the Council of Minister approved the establishment of the National Agency of Coastline (NAC) as a judicial person being under the supervision of the Ministry of Tourism.

The National Agency of Coastline (NAC), shall be responsible for the protection and development of a sustainable environment along the coastal area, by monitoring and supervising all of the existing potential of the coastal and

marine area, and other environmental assets included, and controlling the tourist activities throughout the territory of Republic of Albania in view of a sustainable tourism development.

Apart from inspecting and supervising the implementation of the rules and criteria's for exercising activities throughout the coastline, one of the purposes of National Agency of Coastline, will be to encourage and collaborate with other international or local organizations, institutions and investors in order to invite them to participate and be involved in projects and developments related to the integrated management of the coastal area ■

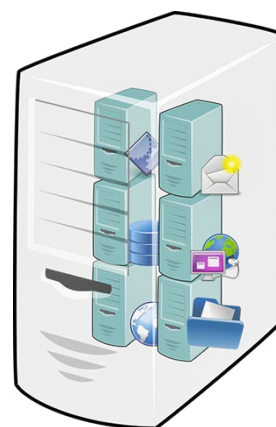
